Greetings,

A number of years ago late at night I meet a young man living in his car in the Giant Eagle parking lot. I was shocked as I looked in his car and his whole life was in this small compact car. My thoughts originally went to, "How can this happen in Venango County? This is where I grew up and this only happens in large cities." I got this man a night from my Alms Fund one night in a local motel. I knew this was a band-aid on a bad situation. As I talked to my colleagues in the Ministerium's I soon found that they had similar experiences and that we needed to do something about it.

In April 2022 with the Ministerium support and many generous gifts we were able to open the first sixteen bed men's homeless shelter, Emmaus Haven, in the Siverly section of Oil City. We are a shelter that assists men in attaining jobs and permanent housing. Now being open a year a and a half we have had over one hundred intakes of homeless men with a seventy percent success rate of placing men in jobs and their own apartments. Becoming a passion for all of us who serve on the Emmaus Haven's board.

We exist totally on grants and your generous gifts. This is truly do God's work in the world here in Venango County. Thank you for your support in prayers in doing this much needed and marvelous work.

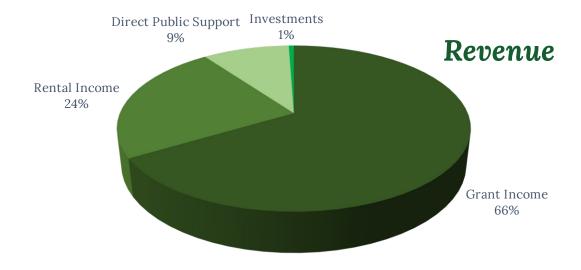

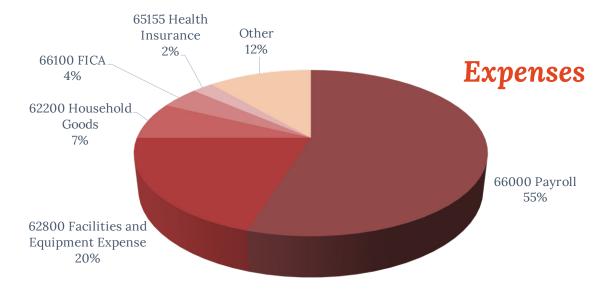
